Roadmap value addition during the IC development and in country partnership building process

Its an important first step in defining a step by step procedure of the process that will be followed in developing the investment case:

- More specifically, the roadmap will:
 - Create the first avenue of understanding each stakeholder's comparative advantage
 - Create a coordination, accountability and monitoring mechanism of the IC development process
 - Creates clarity in the sequence of events and task needed for the finalization of the IC
 - Helps to align participants' activities towards achieving a common agenda and shared goals.
 - The process of the roadmap and its operationalization is of critical value because it's a building block in the development of partnerships that will eventually drive the GFF process in country

The power of collaboration in the IC development process does not come from number of participants but rather from leveraging everyone's core skill/contribution effectively and coordination of their activities.

Suggested Outline of the IC Process Roadmap

1. Background: Where IC process stands, purpose of the IC Roadmap etc.

2. Purpose of the IC: What does the IC seek to achieve in the country, e.g. Prioritize a national health strategic plan, reduce fragmentation in financing etc.

3. Principles of the IC process:

What priniples will guide the process? E.g. It is a collaborative process, it aims to build on previous analytical work, etc.

4. Minimum Requirement for the

IC: these are summarized in the Guidance from GFF Secretariat

Tips for developing matrix of tasks and responsibilities

- Assign roles (tasks/deliverables) in Roadmap & timelines to the different stakeholders, including financing for the activities
- Indicate the deadline for each activity as well as when deliverable is open/closed for feedback
- Look for the comparative advantage that each stakeholder brought on board and agree parameters for engagmenet:
 - Ensure there is clarity on what resources the stakeholder will bring: Is it financial, technical or both?
 - List the Organization & the contact person, including how best to reach them
- List activities which are a Government priority but that no one is supporting. Country platform should discuss & recommend how these will be achieved
 - The end result is a first draft of matrix with tasks and responsibilities
 - Look for resources for priority areas that haven't been supported yet

The IC Task Force

Why

 IC process requires analytical and strategic engagement which is often rigorous and demanding. This requires a select dedicated lean and agile team.

Who

- Lead by Government (normally the Chair of the CP)
- Composition varies
- Normally includes technical partners, experts in RMNCAH-N, health system areas & interested financial and technical partners.
- Clear deliverables are usually laid out in the roadmap
- Consultants with specific skills can be added

Main Tasks

- Drive IC development work forward
- Coordinate inputs from stakeholders
- Produce the deliverables outlined in IC process
- Deliver high quality Investment Case

Frequency of meetings will be determined by the progress on each deliverable, however a bi weekly meeting will allow for continuous engagement prior to debriefing the country platform

In summary: the IC Roadmap





Helps you manage: the IC Roadmap is a management tool to go through a complex multipartner process and get a quality product (Investment Case)



Ensure appropriate stakeholder engagement is outlined in the roadmap to ensure an inclusive process and ownership. Yet not everyone needs to be involved all the time.



Have a Budget & know what resources are available: Non funded activities usually never get done.



It's alive: the IC Roadmap is a living document to be modified as you go forward



Track Progress & document the milestones: The product of these milestones not only act as draft sections of the IC but are also as feedback to Country Platform

Zambia: Work to date

- Established Country Platform modified existing ICC-RMNCAH&N Steering Committee TORs; inclusion of CSOs and private sector
- Held introductory meetings with Cooperating Partners and with CSOs
- Moving towards finalization of key resource documents – RMNCAH&N Roadmap; MTR of the National Health Strategic Plan; 2018 DHS, including equity analysis
- Multi-stakeholder workshop to finalize the RMNCAH&N Roadmap and develop timeline and TA needs for I.C. development

Preparation (Finalize by Dec 31, 2019)

Activity/Task

Understand when different partners that will finance the Investment Case require information

Map out Government planning and budget cycle. When would IC priorities need to be communicated in this process and what is the strategy for influencing planning and budget decision

Collect all relevant strategies and data for the preparation of the IC

Situational Analysis (Finalize by Jan 30, 2020)

Activity/Task

Review and analyze all existing data/evidence and strategies to understand current situation with focus on:

Performance in RMNCAH-N indicators

Key health financing & health system indicators and performance

Root causes of weak performance /Bottleneck analysis

Summarize potential strategies to address weak performance areas/bottlenecks

Initial resource mapping of external financing: who is financing currently, with how much and for what/where? (baseline for IC)

Review trends in Public expenditure: how is money currently being spent (baseline for IC)

Consultations with other line ministries on their potential contribution

Prioritization (Finalize by Feb 29, 2020)

Activity/Task

Cost-effectiveness analysis of benefit package/services

Impact analysis to prioritize health system interventions/Equist

Consult key financiers including MOF to understand their willingness to finance priorities (political/financial feasibility)

Based on potential impact, technical, political & financial feasibility prioritize:
Key RMNCAH-N services
-1-5 most important HSS reforms
-Health financing reforms

Results framework & Costing (Finalize by March 31, 2020)

Activity/Task

Cost IC priorities

Develop theory of change: activities, outcome, output and impact

Develop Results framework with activities (broad description), and baseline, annual and endline targets, sources of data for monitoring as well as a data use strategy

Develop plans to operationalize priority areas with key milestones for first years

Finalizing the Investment Case (By May 15, 2020)

Aggregate plans from prioritization and operationalization stages and identify synergies

Finalize detailed resource mapping and gap analysis based on costed IC priorities

Do second round of prioritization based on refined resource mapping

Develop Investment Opportunity Summary (IOS)

Secure external commitments to IC

Secure domestic commitments to IC

Finalize IC

Review and validation of Investment Case

Submit Investment Case to ICC for endorsement

Submit Investment Case to Honorable Minister of Health for approval



Global Fund current grants, HDF will be coming to an end in 2020

Community Health Strategy been developed and on adoption it was agreed to to develop an investment case.


Globally, to ensure attainment of SDG3, a Global Action Plan for Healthy Lives and Well-being for All was launched at the United Nations General Assembly on 24 September 2019 to guide member countries

Zimbabwe as a signatory to the global international commitments and strives to accelerate progress towards Universal Health Coverage.

National Development Results framework (NDRF) to guide the National Development Plan 1 2021-2025 is now in place

To that extend the MoHCC intends to develop an Investment Case for the Health Sector to guide post 2020 priorities including the Health Resilience for Sustainability Fund (Current HDF) among others.
